# LAST WILL AND TESTAMENT OF Erina Eli Taylor

I, Erina Eli Taylor, residing at 865 Northern Boulevard, Great Neck, New York, 11021, Nassau County, do hereby state that this is my Last Will and Testament, and I revoke all prior Wills and Codicils. This Last Will and Testament was created on 12/03/2024.

## I. FAMILY INFORMATION

My spouse is Eli Taylor and may hereafter be referred to as "my spouse".

As of the date of this Will, I have children, named Bianca Eli Taylor, John Eli Taylor (including all listed).

All references in my Will to "my children" are references to these children.

"My descendants" means my children and their descendants, including descendants of any deceased child.



## II. DISPOSITION OF RESIDUAL ESTATE

All of my residual estate will be distributed to the following beneficiaries in the specified portions:

*As a heartfelt way to establish an enduring legacy: I would like to leave:*

A. **20%** share to be distributed to **Tunnel to Towers Foundation (02-0554654), Staten Island, NY** a non-profit organization.

B. **80%** share to be distributed to **Eli Taylor (Spouse)**.

I. If Eli Taylor (Spouse) does not survive me, the share of Eli Taylor (Spouse) shall be distributed equally to his/her children, else their descendants.

If **Eli Taylor (Spouse)**, **all my children** and all of their descendants do not survive me, their share shall be distributed to the following beneficiaries in noted percentage:

a. **100%** share to be distributed to **Diana Taylor (Grand Child)**.
